
We invest primarily in the junior debt tranches of Collateralized Loan Obligations ("CLOs") with a particular emphasis on CLO debt tranches initially rated 'BB' by National Recognized Statistical Rating Organizations.


# **CLO Overview – A highly diversified pool of loans**<sup>1</sup>

## **Recent Commentary**

- In November of 2023, our Board of Directors declared an increase in monthly distribution from \$0.183 to \$0.21 per share, which became effective with the January 2024 distribution.
- The Fund returned 14.40% since its effective date through December 31, 2023. Returns were driven by continued high SOFR rates as well as appreciation in the price of BBs as the market rallied in the second half of 2023.
- At Dec 31, 2023, the Fund had \$187 million of AUM invested across 33 CLO Notes.
